

Nationwide Auto Recycling Inc. Used Part Limited Warranty & Terms of Sale

1 Year Free Limited Warranty

Our one year limited warranty applies only to engines and transmissions sold from our stock with mileage of under 100,000. All other parts are covered by our standard 6 month limited warranty.

Nationwide may leave accessories on engines and transmissions for your convenience. Engines are sold as long blocks with cylinder heads. Bolt on accessories are not covered under our warranty unless stated on the customer invoice. Bolt on accessories may include alternators, starters, exhaust manifolds, water pumps, fuel pumps, injectors, oil pans, wiring, a/c compressors or other items a manufacturer would not include if you purchased a new long block.

Terms

1. Engines must be installed by a professional repair facility.
2. All fluids, gaskets and timing belts must be changed per manufacturers specifications at time of purchase.
3. Proof of routine maintenance must be presented at time of claim.
4. Parts may only be used for private use unless otherwise stated on the invoice.
5. Commercial applications are not covered by this warranty.
6. Misused, abused or modifications of vehicle or part voids the warranty.
7. Parts sold outside the United States are not covered.
8. Nationwide stamp must be on all engines & transmission at time of sale & return.
9. Parts indicated as sold "AS IS" are not covered by this warranty.
10. Any insurance claim, accident, fire, theft, flood or any circumstance other than normal use of a vehicle voids all warranty.
11. Part must be returned to us, at customers expense for warranty.
12. Warranty is non-transferable unless stated on invoice.
13. No warranty will be honored unless part has been paid in full including all taxes, shipping charges and funds have cleared.
14. Any customer who's funds do not clear at time of purchase, for any reason voids all warranties, even if funds were made good at a later date.
15. Customer agrees to cover all costs associated with the collection of funds for unpaid invoices including legal fees, court fees and interest.
16. Parts ordered incorrectly may be subject to a 20% restocking fee.
17. Special orders or cuts are sold as is, non returnable.

6 Month Standard Limited Warranty

All parts not covered by our 1 year warranty come with a **free** 6 month warranty. Nationwide will replace any defective used auto part for up to six month from date of purchase. If no replacement part is available a refund will be issued. All terms under our term section must be met for warranty claims

Certain used auto parts are sold "as is" some are listed below. Any invoice with "AS IS" stated on it, that part is not covered by any warranty.

1. Air bags and components
2. Used Tires

Important Notices

All invoices must be signed by purchaser at time of sale for warranty to be valid. Part must be stamped / marked by Nationwide.

Refunds will be in the form of company check, credit card or paypal depending on the method of payment. No cash refunds.
